The Rank Group Plc (“Rank” or “the Group”) is pleased to announce the appointment of Peter Johnson as Chairman, to succeed Alun Cathcart who retires from the Board at the end of February 2007.

Currently Peter Johnson is chairman of Inchcape plc and a non-executive director of Bunzl plc. He will join the Board as Deputy Chairman from 1 January 2007 and becomes Chairman on 1 March 2007.

Alun Cathcart has been Chairman of the Group for almost six years. Under his chairmanship, Rank has transformed itself from a broad-based conglomerate into a focused gaming and leisure business.

Ian Burke, Chief Executive of Rank said: “On behalf of the Board I wish to thank Alun for the leading role that he has played in re-shaping The Rank Group. Under his guidance the Group has sold a number of non-core businesses and established a leading position in the UK gaming sector.

“Rank is entering a new phase in its development, adapting to the range of social, regulatory and legislative influences that are changing the UK gaming market. Peter Johnson’s depth of retail experience and his proven qualities of leadership are of great importance to the Group as we seek to grasp the opportunities and to overcome the challenges presented by our changing business environment.”

Rank confirms that there is no information to be disclosed under the requirements of Listing Rule 9.6.13R in relation to this appointment. Peter Johnson does not have any interest in the shares of The Rank Group Plc.
