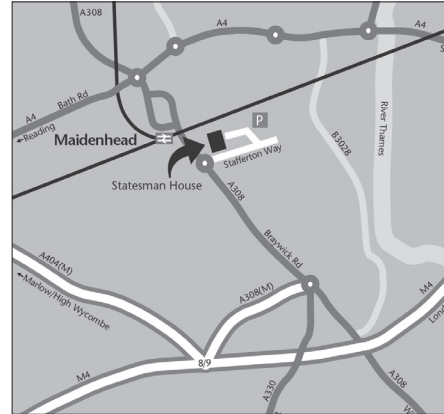

1. M4 to Junction 8/9 (A404)
2. Follow signs for Maidenhead Central (A308)
3. Turn left at the end of the dual carriageway (A308) on to Windsor Road/Braywick Road
4. Stay on this dual carriageway until you come to a roundabout
5. The Rank Group is located on the right-hand side of the roundabout
6. You should turn right at the roundabout into Stafferton Way
7. Take the first left and keep left until you reach the car park to the rear of the building
8. Press intercom to speak to reception

If the proxy is being appointed in relation to less than your full voting entitlement, please enter in the 'Shares' box next to the proxy holder's name the number of shares in relation to which they are authorised to act as your proxy. If the 'Shares' box is left blank then your proxy will be deemed to be authorised in respect of your full voting entitlement (or if this proxy form has been issued in respect of a designated account for a shareholder, the full voting entitlement for that designated account).

An abstention is not a vote in law, which means that the vote will not be counted in the calculation of votes for or against a resolution.
5. A corporation's form of proxy must be executed under its common seal, or under the hand of its officer or attorney, duly authorised in writing.
6. If you are signing this form on behalf of someone else, the power of attorney (or a notarially certified copy) authorising you to sign must be deposited with this form.
7. In the case of joint holders, any one holder may sign the form.

If you return paper and electronic instructions, those received last by the registrar before the latest time for receipt of proxies will take precedence. 9. CREST members may appoint a proxy or proxies electronically via Equiniti (ID RA19). Messages transmitted through CREST must be lodged no later than Tuesday, 13 October 2015 at 11am.
